ORDER No. 38

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Grade-III (DASS) officials in accordance with the instructions contained in OM No.35034/1/97-Estt.(D) dated 9.8.1999 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary (Services) is pleased to grant Second Financial Up-gradation under ACP Scheme in respect of the following Grade-III (DASS) official(s) in the next higher pay scale of Rs. 5000-8000/- w.e.f. the date mentioned against his name to the extent that the pay of the official will be refixed as per the decision of the Govt. of NCT of Delhi in the matter of Pay Scales.

The official concerned may be allowed to exercise his options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the under taking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The concerned Head of Department is requested to ensure before issuing final order that 24 years of regular service of the official does not include the period of past service rendered in Autonomous body/Statutory body/State Govt. as the period of past service in these bodies is not to be counted for grant of financial upgradation under ACP Scheme. (Clarification No. 43 of DOPT OM dated 18.07.2001).

If the official is on deputation, he will get financial up gradation from the date shown against his name only on notional basis. However, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.

The Head of Departments/Head of Offices are requested to ensure before issuing the final order that the above official has fulfil the requirement as mentioned in Point No. 4 and 5.1 of Annexure-1 of ACP Scheme introduced by DoPT, Government of India.

The concerned Head of Department/Head of Office is, however, requested before issuing the formal orders for the grant of 2nd financial upgradation in respect of the above official, to confirm again that the official has completed 24 years of regular service in the Govt. of NCT of Delhi on the date of granting financial upgradation without or with one promotion since the date of his initial appointment in the service and is clear from Vigilance angle.
