The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up gradation under the Modified Assured Career Progression Scheme.

However, the grant of higher grade pay is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered.

The Head of Department concerned are requested to ensure before issuing final orders that 10 years of regular service of the official does not include the period of service rendered in State Government/ statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point No.10 of DoPT OM dated 19.05.09).

The concerned Head of Department are requested to issue formal order for grant of 1st financial up gradation in respect of above mentioned officials working in their Department and before issuing the formal orders to again confirm that the officials have completed 10 years of regular service since the initial appointment in the service and are clear from Vigilance Angle.

The official in case, on deputation will get financial up gradation from the date shown against his name only on notional basis. However, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
