On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to Grade-III (DASS)/Sr. Assistants in accordance with the instructions contained in Office Memorandum no. 35034/1/97-Estt.(D) Dated 9.8.99 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), Secretary Services is pleased to grant Second Financial Upgradation under ACP Scheme to the following 05 Gr-III (DASS)/Sr. Assistants on completion of 24 years of regular service from the pay scale of Rs. 4000-6000/- (Pre- revised) to next higher grade in hierarchy of DASS Cadre of Rs. 5500-9000/- (Pre-revised) w.e.f. the date mentioned against their names. :

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Departments are requested to issue formal orders for grant of 2nd financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of departments may again confirm that the official concerned has completed 24 years regular service with one promotion since the date of his initial appointment in the service and the official concerned is clear from vigilance angle.

The Head of Department concerned are requested to ensure before issuing final order that 24 years regular service of the officials does not include the period of service rendered in State Government/Statutory Body/ Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under ACP Scheme.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government .
