ORDER 63

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to **Gr.II(DASS)/Assistant Section Officers** in accordance with the instructions contained in Office Memorandum no. 35034/1/97-Estt.(D) Dated 09.08.1999 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), the Secretary (Services) is pleased to grant **2nd Financial Upgradation under ACP Scheme** to the following **03 Gr.II(DASS)/Assistant Section Officers** on completion of 24 years of regular service from the pay scale of Rs. 5500-9000 (pre revised as per 5th CPC; revised as Rs. 9300-34800 with grade pay of Rs. 4600/-, 6th CPC) to next pay scale of Rs. 6500-10500 (pre revised 5th CPC; revised as 9300-34800 with grade pay of Rs. 4800/-, 6th CPC) w.e.f. the date mentioned against their names:

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.


The concerned Head of Departments are requested to issue formal orders for grant of 2nd financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of departments may again confirm that the official concerned has completed 24 years regular service with one promotion since the date of his initial appointment in the service and the official concerned is clear from vigilance angle.

The Head of Department concerned is requested to ensure before issuing final order that 24 years regular service of the officials does not include the period of service rendered in State Government/Statutory Body/ Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under ACP Scheme.


