The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher grade pay is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered.

In case the official has been redeployed in Govt. of NCT of Delhi, HOD, may ensure before issue, final order that the official has not been given financial upgradation before completion of 10 years of regular service.
