ORDER 17

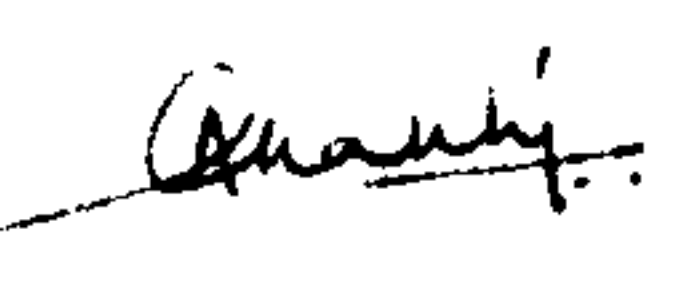

The Officers concerned may be allowed to exercise their options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the MACP Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

In case of employees declared surplus and redeployed in Delhi Govt., HODs may ensure before issue of final orders that concerned officials have not been given more than one financial upgradation / promotion and completed 20 years of regular service for 2nd Financial upgradation during their tenure including past services at DEDA/DSMDC prior to redeployment in GNCT of Delhi.

The concerned Head of Departments are requested to issue formal order for grant of the 2nd financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 20 years regular service with one financial upgradation / promotion and are clear from Vigilance angle.
