**ORDER NO. 24.**


In pursuance of directions of Hon'ble CAT order dated 02.08.2016 in the matter of OA No.2938/2014 titled Smt. Balbir Kaur V/s GNCTD & Ors and on the recommendations of the Screening Committee constituted for grant of 2<sup>nd</sup> financial upgradation under the Modified Assured Career Progression Scheme in accordance with the instructions contained in OM No.35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary(Services) is pleased to grant the 2nd financial upgradation under MACP Scheme on completion of 20 years of regular service with one financial upgradation in the pay scale of Rs.5200-20200/- from the existing Grade Pay of Rs.2400/- to the immediate next higher Grade pay of Rs.2800/- in the hierarchy of the revised pay bands w.e.f. the date mentioned against the name :-
