On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression (ACP) Scheme to Grade-III (DASS) in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) Dated 09.08/1999 issued by Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training) of Govt. of India and Circular Dated 29.07.2015 issued by Services Department, Govt. of NCT of Delhi for counting of past service for the purpose of grant of benefits under ACP/MACP Scheme in respect of Officials who were redeployed in GNCT of Delhi after being declared surplus at DEDA / DSMDC, the Secretary (Services) is pleased to grant benefits of 1<sup>st</sup> Financial Upgradation under ACP Scheme to Officials redeployed from DEDA/DSMDC from the existing pay scale of Rs. 3050 – 4590 to the next higher grade in accordance with the existing hierarchy of posts in DASS Cadre i.e. Gr.III (DASS)/UDC in the pay scale Rs.4000– Rs.6000 w.e.f. the date mentioned against their names:

In case of employees declared surplus and redeployed in Delhi Govt., HODs may ensure before issue of final orders that the concerned Official has not been given any financial upgradation / promotion and completed 12 years of regular service for 1<sup>st</sup> Financial upgradation during their tenure including regular service prior to redeployment in GNCT of Delhi. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits. Any financial upgradation already granted to these officials without counting of past service in DEDA/DSMDC shall stands modified accordingly.

The Officers concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.


The concerned Head of Departments are requested to issue formal order for grant of the 1<sup>st</sup> financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these Officials have completed 12 years regular service with no promotions or 12 years of continuous service in the same grade pay and are clear from Vigilance angle.
