On the recommendations of the Screening Committee constituted for grant of financial upgradations under the Modified Assured Career Progression Scheme to Gr. III (DASS) in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training) & in pursuance of directions of Hon'ble Courts, Delhi, in various cases for counting of past service for benefits of ACP/MACP scheme to the official having rendered initial services in DEDA & further re-deployed in GNCT of Delhi after being declared surplus, the Secretary (Services) is pleased to grant 2nd Financial Upgradation under MACP Scheme on completion of 20 years of regular service with only one financial upgradation /promotion from the existing pay scale of Rs. 5200-20200 with GP of Rs. 2400/- (PB-I) to immediate next higher Grade Pay of Rs. 2800 (PB-I) to the following official w.e.f. the date mentioned against his name :-

The Official concerned may be allowed to exercise their, options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the MACP Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The official was declared surplus and redeployed in Delhi Govt. from DEDA. HOD may ensure before issue of final order that the official has not been given more than one financial upgradation / promotion and completed 20 years of regular service for 2<sup>nd</sup> Financial upgradation after counting past services at DEDA.

The concerned Head of Department is requested to issue formal order for grant of the 2nd financial upgradation in respect of the above mentioned official. However, before the issuance of the formal orders the Heads of Departments may again confirm that the official has completed 20 years regular service with only one financial upgradation / promotion for 2<sup>nd</sup> financial upgradation under MACP scheme and is clear from Vigilance angle.
