The Official concerned may be allowed to exercise their, options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the MACP Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The official was declared surplus and redeployed in Delhi Govt. from DEDA. HOD may ensure before issue of final order that the official has not been given more than two financial upgradation / promotion and have completed 30 years of regular service for 3^{rd} financial upgradation after counting past services at DEDA .

The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned official.
