On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Gr-IV(DASS) officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Government of India, Department of Personnel & Training, the Secretary (Services) is pleased to grant 1<sup>st</sup> financial upgradation under MACP Scheme to the following 04 Gr-IV(DASS) officials, who were initially appointed as Gr-IV(DASS)/LDC directly or through Absorption in the pay scale of Rs. 5200-20200 with Grade pay of Rs. 1900/- to the immediate next higher Grade pay of Rs.2000/- in the hierarchy of the revised bands on completion of 10 years of regular service without any promotion w.e.f. the date mentioned against their names:-

The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher grade pay is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered.

In case the official has been redeployed in Govt. of NCT of Delhi, HOD, may ensure before issue final order that the official has not been given financial upgradation before completion of 10 years of regular service.

The concerned Head of Department are requested to issue formal order for grant of 1<sup>st</sup> financial upgradation in respect of above mentioned officials working in their Department and before issuing the formal orders to again confirm that the officials have completed 10 years of regular service since the initial appointment in the service and are **clear from Vigilance Angle**.

The official in case, on deputation will get financial upgradation from the date shown against his name only on notional basis. However, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
