On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Gr-IV(DASS) officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Government of India, Department of Personnel & Training, the Secretary (Services) is pleased to grant 2nd financial upgradation under MACP Scheme w.e.f.01.09.08 date of implementation of MACP Scheme or on completion of 20 years of regular service with promotion in the pay scale of Rs.5200-20200/- from the existing Grade Pay of Rs.2400/- to the immediate next higher Grade pay of Rs.2800/- in the hierarchy of the revised pay bands w.e.f. the date mentioned against the name :-

The official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from his pay.

In case of employee declared surplus and redeployed in Delhi Govt., HOD may ensure before issue of final order that concerned official has not been given more than one financial upgradation/promotion and completed at least 20 years of regular service for 2nd financial upgradation during his tenure including service prior to redeployment in Govt. of NCT of Delhi and is **clear from vigilance angle**.
