On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Gr-IV(DASS) officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Government of India, Department of Personnel & Training, the Secretary (Services) is pleased to grant the following 11 Gr.-IV(DASS) officials. 3rd financial upgradation under MACP Scheme, who were initially appointed as Class-IV employees and granted two financial upgradation/promotion (including in-situ promotion) before 01.09.08. Since two financial upgradations/promotions were granted before 01.09.08 i.e introduction of MACP Scheme, the officials are eligible for 3rd financial upgradation under MACP Scheme in the grade pay of Rs.2400/- in the hierarchy of the revised bands on completion of 30 years of regular service w.e.f. the date mentioned against their names :-

The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up gradation under the Modified Assured Career Progression Scheme.

However, the grant of higher grade pay is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered.

The concerned Head of Department are requested to issue formal order for grant of 3rd financial upgradation in respect of above mentioned officials working in their Department and before issuing the formal orders to again confirm that the officials have completed 30 years of regular service since the initial appointment in the service and are **clear from Vigilance Angle**.

The official in case, on deputation will get financial upgradation from the date shown against his/her name only on notional basis. However, he/she will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government


