**ORDER NO. 44**

In compliance of Hon'ble High Court order dated 23.08.16 in the matter of W.P.C. No.3500/2007 titled "Chief Secretary & Ors Vs P.K. Sharma & Hon'ble CAT Order Dated 09.11.2006 in the matter of O.A. No. 8/2004, and on the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Gr. II (DASS)/Head Clerk officials in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary (Services) is pleased to grant of 3<sup>rd</sup> financial upgradation to the following 01 case of Gr. II (DASS)/Head Clerk officials on completion of 30 years of regular service with two promotion, from the corresponding Pay Band-II of Rs. 9300-34800/- Grade Pay 4600/- to the immediate next higher Grade Pay of Rs. 4800/- in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against their name:

Further this Department Order No. 22 issued vide No.F.13(1)/2013/MACP/UDCS/20Y/Services/983-996 dated 19.09.13, is being modified to the extent that the eligibility date for grant of 2<sup>nd</sup> MACP benefit to Sh. Pushkar Kumar Sharma as mentioned at Sl. No. 93 may be read as 01.09.08 instead of 04.11.2008. The rest of the contents of said order shall remain unchanged.

The Official concerned may be allowed to exercise their, options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department are requested to issue formal order for grant of the 3<sup>rd</sup> financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 30 years regular service with two promotions since the date of their initial appointment in the service and are **clear from Vigilance angle**.


