On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme (ACP) to Gr. III (DASS) in accordance with the instructions contained in OM NO. 35034/1/97-Estt.(D) Dated 09/08/1999 issued by Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training) of Govt. of India and Circular Dated 29.07.15 issued by Services Department, Govt. of NCT of Delhi for counting of past service for the purpose of grant of benefits under ACP/MACP scheme in respect of Officials who were redeployed in GNCT of Delhi after being declared surplus from DEDA / DSMDC, the Secretary (Services) is pleased to grant benefits of 1st Financial upgradation under ACP Scheme to Officials Redeployed from DEDA/ DSMDC with pay protection from the existing pay scale pay scale of Rs. 3050 - 4590 to the next higher grade in accordance with the existing hierarchy of posts in DASS Cadre i.e. Gr.III (DASS)/UDC in the pay scale Rs.4000- Rs.6000 w.e.f. the date mentioned against his name:

The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.


The official are declared surplus and redeployed in Delhi Govt. from DEDA/DSMDC. Respective HODs may ensure before issue of final orders that the Official have not been given any financial upgradation / promotion and has completed 12 years of regular service after counting past services at DEDA/DSMDC. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits. Any financial upgradation granted to the official without counting of past service at DEDA/DSMDC shall stand modified accordingly.

The concerned Head of Departments are requested to issue formal order for grant of the 1st financial upgradation in respect of the above mentioned official. However, before the issuance of the formal orders the Heads of Departments may again confirm that the officials have completed 12 years regular service with no promotions or 12 years of continuous service in the same grade pay and are clear from Vigilance angle.
