In supersession of this Department Order No. 35 issued vide F.No.1(1)2004/ACP/Gr.III(Steno)/767-773 dated 22.08.2005, on the recommendations of the Review Screening Committee constituted in accordance with the instructions contained in O.M No. 35034/1/97-Estt.(D) dated 09/08/1999 issued by Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training) of Govt. of India. First Financial Upgradation under ACP scheme granted to Sh. L.K.Dagar, Stenographer Gr.II has been reviewed and Secretary (Services) is pleased to grant 1st financial upgradation under ACP Scheme to the official from the existing pay scale of Rs. 4000-Rs. 6000 to next higher grade i.e. Rs.5500-Rs.9000 w.e.f. 14.09.2001 after counting of past services rendered at DSMDC in terms of Circular dated 29.07.2015 and Para No. 14 of Annexure-I of DoPT, GOI O.M. Dated 09.08.199.

The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The official has been declared surplus and redeployed in Delhi Govt. from DSMDC. Head of Department may ensure before issue of final orders that the Official has not been given any financial upgradation/promotion and has completed 12 years of regular service after counting past services rendered at DSMDC. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits.

The concerned Head of Department is requested to issue formal order for grant of the 1st financial upgradation in respect of the above mentioned official. However, before the issuance of the formal order the Head of Department may again confirm that the official has completed 12 years of regular service with no promotions or 12 years of continuous service in the same grade pay and is clear from Vigilance angle.
