On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Government of India, Department of Personnel & Training the Secretary (Services) is pleased to grant the following 01 Gr-III(DASS)/UDC official who were initially appointed as Enumerator in Urban Development Department and later taken on Cadre strength of Govt. of NCT of Delhi as Gr.III(DASS)/UDC vide notification of Services-IV Branch dated 16.04.07, on the completion of 20 years of regular service for grant of 2nd financial upgradation from existing grade pay of Rs.4200/- to the immediate next higher grade pay of Rs.4600/- w.e.f. the date mentioned against the name :-

The official may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered from her pay.

In case of employee encadred and redeployed in Delhi Govt., HOD may ensure before issue of final order that concerned official has not been given more than one financial upgradation/promotion and completed at least 20 years of regular service for 2nd financial upgradation during his tenure including service prior to redeployment in Govt. of NCT of Delhi.

The concerned Head of Department is requested to issue formal order for grant of the 2nd financial upgradation in respect of above mentioned official working in their Department. However, before issuing formal order again confirm that the official is clear from Vigilance Angle.
