ORDER 66

On the recommendations of the Internal Committee constituted for grant of Non Functional Selection Grade to Gr.III(Steno) vide OM No.F.3(5)(1)/NFSG/ S.III/2015/987-992 dated 29.04.2015 in accordance with the instructions contained in office memorandum no.20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), the Secretary (Services) is pleased to grant **Non Functional Selection Grade** to the following **Gr.III(Steno)** in the pay scale pay scale of Rs. 9300-34800 in PB - II with Grade Pay of Rs.4200/- (Level- 6 of pay matrix table under 7th CPC i.e. Rs. 35,400-1,12,400 revised), w.e.f. the date mentioned against their names:

Non Functional Selection Grade to above mentioned Gr.III(Steno) is on the basis of eligibility list provided by Cadre Controlling Authority i.e. Services-III Department in respect of Gr.III(Steno). It is subject to the condition that, in future, due to addition or deletion of names in the eligibility list, if there is a change in the date of eligibility in respect of above concerned Gr.III(Steno), they will have no claim over the date of eligibility. HODs are requested to obtain an Undertaking from the concerned official to this effect

Further, Non Functional Selection Grade is subject to the undertaking that in the event of over payment, which may be detected at later stage, the same will be recovered from their pay.

The concerned Head of Departments are requested to issue formal orders for grant of Non-Functional Selection Grade in respect of officials working in their departments, complying DoPT OM no. 20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), and order no. 58 dated 03.02.2015 of Services Department. However, before the issuance of the formal orders the Head of Departments may again confirm that these officials are clear from vigilance angle.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the Non Functional Selection Grade.


The officials who are on deputation will get Non Functional Selection Grade from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
