In compliance of Hon'ble High Court order dated 24.11.17 in the matter of W.P.C. No.10337/2017 titled "Govt. of NCT of Delhi & Ors Vs N. K. Rohatgi and on the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Gr. III (DASS)/UDC official in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 3rd financial upgradation to Sh. N. K. Rohatgi, the then Gr. III (DASS)/UDC (Now Retd. AAO) on completion of 30 years of regular service with two promotion/financial upgradation, from the corresponding Pay Band-II of Rs. 9300-34800/- Grade Pay 4600/- to the immediate next higher Grade Pay of Rs. 4800/- in the hierarchy of the recommended revised pay bands w.e.f. the date mentioned against his name:

The Official concerned may be allowed to exercise options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned official working in the Finance Department. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 30 years regular service with two promotions/financial upgradation and are clear from Vigilance angle.

The official who are on deputation will get financial upgradation from the date shown against his name only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.

Further the official who are appointed on adhoc basis will get benefit of financial upgradation on reversion to the lower post or if it is beneficial vis-a vis the pay drawn on adhoc basis.
