On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Gr-III (DASS)/S.A officials in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 2nd financial upgradation under MACP Scheme to the following 04 Gr-III (DASS)/S.A. officials on completion of 20 years of regular service with one promotion/financial upgradation or 10 years of continuous service in the same Grade Pay, from existing pay scale of Rs. 5200-20200/- with Grade Pay 2400/-to the immediate next higher Grade Pay of Rs. 2800/- in the hierarchy of the recommended revised pay bands w.e.f. the date mentioned against their names:

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of Departments concerned are requested to ensure that 20 years regular service of the officials does not include the period of service rendered in State Government/Statutory Body / Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09)

The concerned Head of Departments are requested to issue formal order for grant of the 2nd financial upgradation under MACPS in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of Departments may again confirm that these officials have completed 20 years regular service with one promotion/financial upgradation or 10 years of continuous service in the same pay scale and are clear from Vigilance angle.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
