However, the grant of higher pay scale is subject to the undertaking that in the event of everpayment, which may be detected at a later stage, the same will be recovered from their pay.

The official concerned may be allowed to exercise his/her option, if any, under FR 22 vithin one month of the issuance of the order granting the financial up-gradation under the Assured Career progression Scheme.

The concerned Heads of Departments are requested to ensure before issuing final order that officials are clear from vigilance angle and the Class IV employes have not been given in-situ promotion and fast-track promotion availed through limited departmental competitive examination.

The officials who are on deputation will get financial up gradation from the dates shown against their names **only on notional basis**, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.

The concerned Heads of Departments are requested to ensure before issuing final order that 12 years of regular service of the officials does not include the period of past service rendered in Autonomous body/Statutory body/State Govt. as the period of past service in these bodies is not to be counted for grant of financial up-gradation under ACP Scheme. (Clarification No.43 of DOPT OM dated 18.7.2001)

The concerned Heads of Departments/Heads of Offices are, however, requested before issuing the formal orders for the grant of 1<sup>st</sup> financial upgradation in respect of the above officials, to confirm again that these officials have completed 12 years of regular service in the Govt. of NCT of Delhi on the date of getting financial up-gradation without or with one promotion since the date of their initial appointment in the service, and are clear from vigilance angle.
