

Sub: Tamil Nadu Electricity Regulatory Commission – Selection for the posts of Member (Legal) and Member in Tamil Nadu Electricity Regulatory Commission – Applications called for- Regarding.

Ref: 1. G.O (Ms).No.13, Energy (D1) Department, dated 04.03.2022  
2. G.O (Ms).No.23, Energy (D1) Department, dated 13.04.2022

I am directed to state that the post of Member in Tamil Nadu Electricity Regulatory Commission is vacant from 18.03.2022 and the post of Member (Legal) will be vacant from 06.05.2022. The Government of Tamil Nadu in terms of Section 85(1) of the Electricity Act, 2003, have constituted Selection Committee in the Government Orders cited for the purpose of selection of the posts of Member and Member (Legal) of the Tamil Nadu Electricity Regulatory Commission. The term of Office and conditions of service of the person finally selected for appointment to the posts of Member and Member (Legal) shall be as per the provisions contained in the Electricity Act, 2003.

2. I am to state that Section 84(1) of the Electricity Act, 2003 provides as follows:-

"Section 84. (Qualifications for appointment of Chairperson and Members of State Commission): (1) The Chairperson and the Members of the State Commission shall be persons of ability, integrity and standing who have adequate knowledge of, and have shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management".

3. In terms of section 89(1) of the Electricity Act, 2003, the Member shall hold the post for a term of 5 (five) years from the date he/she joins the office or till he/she attains the age of 65 years, whichever is earlier and that as per section 84(3) of the said Act, the Member shall not hold any other office during this period. In this regard, the Term of office and Conditions of service of the Member are governed by section 89 of the said Act. The salary, allowances and other terms and conditions of service of the Member shall be governed by the Tamil Nadu Electricity Regulatory Commission (Salary, Allowance and Conditions of Services of the Chairperson and other Members etc.) Rules, 2004 as amended from time to time.

4. I am, therefore, to request you to forward the application of persons/Officers possessing requisite qualification and experience for selection to the posts of Member and Member (Legal) of Tamil Nadu Electricity Regulatory Commission as detailed above, so as to reach the Government of Tamil Nadu on or before 16-5-2022 along with two copies of CVs/dossiers of the personals eligible. Further, in respect of persons in service, copies of their Annual Confidential Reports (ACR) Dossiers covering a period of last 5 (five) years may be enclosed.


