### VACANCY CIRCULAR

Subject: Recruitment to one vacancy(tentative) against the post of Executive Director (ED) in Nehru Yuva Kendra Sangathan (NYKS), an autonomous organization under the Government of India on deputation basis (ISTC) (Pay Level 13 of pay matrix as per 7th CPC) - reg.

Nehru Yuva Kendra Sangathan (NYKS) is an autonomous body under the administrative control of the Ministry of Youth Affairs and Sports. Nehru Yuva Kendras were established in the year 1972 with the objective of providing rural youth avenues to take part in the process of nation building as well providing opportunities for the development of their personality and skills. NYKS is funded from Grant in Aid from Government of India.

- Applications are invited for filling up of one(1) vacancy(tentative) against the post of ED in NYKS on Deputation basis(ISTC). Applicants must be Officers under the Central/State Govt./Autonomous bodies/ Universities: holding analogous posts on regular basis OR with 5 years regular service in the post with pay level 12 in the pay matrix, Rs. 78800-209200 OR with 10 years regular service in the post with pay level 11 in the pay matrix, Rs. 67700-208700.
- The appointment will be made on deputation basis for a period of three years and will 3. be governed by the instructions issued by DOPT vide OM No. 6/8/2009-Estt.(Pay II) dated 17.06.2010, as amended from time to time. The maximum age limit for appointment on deputation basis shall not be exceeding 56 years as on closing date of receipt of applications by this department. Applicants, who have applied in response to previous vacancy circular for the post of ED(NYKS), are required to apply afresh.
- 4. The post of ED under NYKS is not an entitled office for Govt. accommodation under the General Pool of Govt. accommodation. Medical reimbursement is admissible as per the NYKS Service Rules. This is in lieu of CGHS benefits which are not admissible to the employees of NYKS.

- 6. Period of Deputation:

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the central Govt. shall ordinarily not exceed three years.

7. Age and Crucial Date for determining Eligibility:

The maximum age limit shall be not exceeding 56 years as on the closing date of receipt of application.

Applications of only such officers will be considered which are routed through proper channel and are accompanied with (i) bio-data in the proforma at Annexure-II; (ii) clear photocopies of the up-to-date CR dossiers of the officer for the last five years, duly attested by a Group 'A' officer (iii) cadre clearance; (iv) clearance from vigilance and disciplinary angle; and (v) statement giving details of major or minor penalties, if any, imposed on the officer during the last ten years.

- \*\* The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
