OFFICE MEMORANDUM

Sub: Coverage under Central Civil Services(Pension) Rules, in place of NPS of these employees who were recruited against the posts/vacancies notified for recruitment, on or before 01.01.2004.

This Department has received many representations from the officials of Govt. of NCT of Delhi, who were appointed in the year 2004 on compassionate ground, for extending the benefits of Old Pension Scheme i.e. benefits under CCS (Pension) Rules 1972 now CCS (Pension) Rules, 2021 on the basis of Office Memorandum No.57/04/2019-P&PW(B) dated 17.02.2020 of Department of Personnel and Training, Govt. of India.

2. In this regard, it is informed that the above Office Memorandum No.57/04/2019-P&PW(B) dated 17.02.2020 of Department of Personnel and Training, Govt. of India extends the benefits of CCS (Pension) Rules 1972 now CCS(Pension) Rules, 2021 to those employees who were recruited in Government Services on the basis of advertisement published/notified on or before 31.12.2003.

3. It is further informed that as per clarification contained in the Department of Personnel and Training, Govt. of India Office Memorandum No.57/04/2019-P&PW(B) dated 25.06.2020, *the officials appointed on compassionate ground are entitled for benefits of CCS (Pension) Rules 1972 now CCS (Pension) Rules, 2021 where the Competent Authority accepted the recommendation of the Screening/Selection Committee before 01.01.2004.*

4. To take a decision on the representations it is informed that as per record available in Services Department, the Screening Committee, Govt. of NCT of Delhi recommended the cases of 197 candidates in its meeting held on 19.12.2003 which continued till 12.01.2004 and the recommendations of the Screening Committee were accepted by the Competent Authority i.e. the then Chief Secretary, Delhi on 22.01.2004

5. In view of the above information, the Competent Authority of respective departments, Govt. of NCT of Delhi i.e. the Appointing Authority in respect of the officials working in their departments may take decisions on their representations on the above subject.

6. This issues with the prior approval of the Competent Authority.
