Subject: - Posting of Eligible Officer as Assistant Commissioner/Deputy Director in Delhi Jal Board on deputation basis, reg.

Sir,

I am directed to invite your kind attention on the above captioned subject.

In this regard, it is informed that there are 15 posts of Assistant Commissioner/ Deputy Director (R) available in Delhi Jal Board out of which at present only 06 posts are filled in and 09 posts are lying vacant. Due to the large number of vacant posts, Delhi Jal Board is facing shortage of Assistant Commissioner/Deputy Director (R) adversely hampering the functioning of Administration/ Revenue Wing of our organisation. In the past Services Department of GNCTD have posted eligible officers as Assistant Commissioner/ Deputy Director in Delhi Jal Board on deputation basis. In case of deputation notified RRs provides the following qualification:-

Officers under the Central / State Government/ Union Territories Administrations:-

(a) (i) holding analogous post on regular basis in the parent cadre/department

Or

(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in Pay band-2 in the scale of pay of Rs. 9300-34800/- with Grade pay of Rs. 5400/- or equivalent in the parent cadre/department; or

(iii) with six years' service in the grade rendered after appointment thereto on a regular basis in posts in the Pay Band - 2 in the scale of pay of Rs. 9300-34800/- with Grade pay of Rs. 4800/- or equivalent in the parent cadre/department; and

- (b) Possessing the following educational qualification and experience:-
 - (i) Degree from a recognized University/Institute.
 - (ii) Five years' (experience in Administrative and Establishment matters.
