SUB: - Filling up of vacant post in Wildlife Crime Control Bureau – reg.

The Wildlife Crime Control Bureau (WCCB) is a multidisciplinary statutory body constituted under the Wild Life (Protection) Act, 1972, for combating organized wildlife crime in the country. The Bureau HQ is located in New Delhi and these vacancies are to be filled up on deputation basis for various offices of WCCB as indicated against each vacancy.


