On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression(MACP) Scheme to Grade-IV (DA55)/Jr. Assistant officials in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 & 22.10.19 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary (Services) is pleased to grant 2nd financial upgradation under MACP Scheme to the following Grade-IV (DA55)/Jr. Assistant officials on completion of 20 years of regular service with one promotion/financial upgradation, from existing pay scale of Rs. 5200-20200/- with Grade Pay 1900/- (Revised Level 2 in pay matrix of 7th CPC) to the immediate next higher Grade Pay of Rs. 2000/- (Revised Level 3 in pay matrix of 7th CPC) in the hierarchy of the recommended revised pay bands w.e.f. the date mentioned against their names:

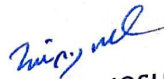
The grant of MACP is further subject to the condition that:

- 1) The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- 3) Officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.

4) The concerned Head of Departments are requested to ensure before issuance of formal order for grant of 2nd financial upgradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.

5) It should be ensured by concerned Head of Departments that the above-mentioned officials are absolutely clear from vigilance angle at all levels. Integrity Certificate in prescribed format should also be checked & verified by Head of Departments.

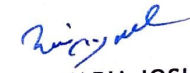

Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official(s) may not be implemented till clarification from this Department.
