
**Note 3:** The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for considering appointment by promotion. Period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other organization/department of the Central Govt. Shall not exceed 3 years.

2. Since the SDMC follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of deputation of the Govt. of India shall be applicable mutatis mutandis to the officer on deputation basis in South Delhi Municipal Corporation. Further, the maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

3. Earlier the last date of receipt of application was 08.01.2022. With the approval of competent authority the last date of receipt of application has been extended for further 30 days.
