**ORDER** 190

On the recommendations of the Internal Committee constituted for grant of Non Functional Selection Grade to Grade-III(DASS)/Senior Assistants vide OM No.F.3(5)(1)/NFSG/ S.III/2015/987-992 dated 29.04.2015 in accordance with the instructions contained in DoPT, Govt. of India O.M No.20/49/2009-CS-II(B) dated 22.06.2011, the Secretary (Services) is pleased to grant **Non Functional Selection Grade(NFSG)** to the following **Grade-III(DASS) /Senior Assistants** in the Level- 6 of pay matrix table under 7<sup>th</sup> CPC i.e. Rs. 35,400-1,12,400/- (Pre-revised Pay Scale of Rs. 9300-34800 in PB - II with Grade Pay of Rs.4200/-) w.e.f. the date mentioned against their names:

Non-Functional Selection Grade to above-mentioned Grade-III(DASS)/ Senior Assistants have been granted on the basis of Eligibility list provided by Cadre Controlling Authority i.e. Services-II Department, Govt. of NCT of Delhi in terms of No.F.3(5)(1)/NFSG/ S.III/2015/987-992 dated 29.04.2015.

The grant of NFSG benefits is subject to the condition that if there is a change in the date of eligibility list in respect of above-mentioned Grade-III(DASS)/Senior Assistant in future, due to addition or deletion of names in the eligibility list, they will have no claim over the date of eligibility. The respective Head of Departments are requested to obtain an Undertaking from the concerned official to this effect.

The Officials who have been granted MACP benefits in Rs.2800/- G.P will not get any increment at the time of pay fixation on grant of NFSG benefits in terms of DoPT, Government of India OM No.25/7/2019-CS.II(B) Dated 27.08.2019, which has been endorsed by Services Department vide letter No.20/17/2015/S-I/Lit./336 dated 02.02.2021 and accordingly, only the difference in Grade Pay (i.e 4200-2800=1400) should be allowed.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the Non Functional Selection Grade (NFSG).

Further, grant of Non Functional Selection Grade is subject to the undertaking that in the event of over payment, which may be detected at later stage, the same will be recovered from their pay.

The officials who are on deputation will get Non Functional Selection Grade from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.

The concerned Head of Departments are requested to issue formal orders for grant of Non-Functional Selection Grade in respect of officials working in their departments in pursuance to DoPT OM no. 20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), and order no. 58 dated 03.02.2015 of Services Department, Govt. of NCT of Delhi. However, before the issuance of the formal orders the Head of Departments may verify that the service particulars mentioned above are correct and these officials are clear from vigilance angle.


