

Chhattisgarh State Electricity Regulatory Commission (CSERC) has been reconstituted vide Energy Department Notification No. 1825/F1-2/2018/13/1/ED Naya Raipur dated 30th June 2018 by the Government of Chhattisgarh under Section (82) of the Electricity Act, 2003 (No. 36 of 2003). Accordingly, the reconstituted Commission now consists of three members including the Chairperson of the Commission.

 - Section 84(2) of the said Act is only an enabling provision to appoint a High Court Judge as a Chairperson of the State Commission of the said Act and it is not mandatory to do so.
 - It is mandatory that there should be a person of law as a Member of the Commission, which requires a person, who is, or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.
 - That in any adjudicatory function of the State Commission, it 111. is mandatory for a member having the aforesaid legal expertise to be a member of the Bench.


