The matter with regard to review of reservation policy to maximize the reservation for Ex-servicemen in Government jobs has been under reference with Govt. of India, Ministry of Home Affairs.

MHA, Govt. of India, vide letter dated 02nd March, 2020 (copy enclosed), in consultation with DoP&T, inter-alia, reiterated the DoP&T's notification dated 04.10.2012, whereby Ex-servicemen (Re-employment in Central Civil Services and Posts) Amendment Rules, 2012 were notified (copy enclosed).

Since in service matters including reservation, the Government of N.C.T. of Delhi, being Union Territory, follows the OMs / instructions etc. issued by Govt. of India from time to time, the clarification received vide above-mentioned letter dated 02.03.2020 of MHA, GoI alongwith its enclosures is annexed for information.

- This file has been received from Government of NCT of Delhi (GNCTD), through Ministry of Home Affairs, stating that they follow the instructions received from Government of India, in respect of reservation policy. They have sought a copy of instant policy of reservation for the ex-servicemen, in the posts and services of the Central Government.
- 3. GNCTD intimated that after the implementation of the 6th CPC, Group 'D' posts did not exist in their establishment and that many group Ç' posts have been merged with Group B' posts.
- In this context, it may be stated that a proposal had been received from Department of Ex-servicemen Welfare to increase quota for ex-servicemen from the existing 10% to 20% in Group C and creation of 10% fresh quota for ex-servicemen in direct recruitment in group B (non-Gazetted) posts. However, after consideration of the proposal, in consultation with other Ministries/Departments, including Ministry of Home Affairs, DoPT decided that the proposal, if agreed to, will not serve the desired purpose, as the already prescribed percentage of reservation for exservicemen has not yet got filled up.
- A copy of Notification, dated 04.10.2012, i.e. the current policy of reservation for Ex-servicemen in the posts and services of the Central Government, is annexed.

New Delhi, the 4th October, 2012

- GS.R. 757(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Ex-servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979, namely:-
 - (1) These rules may be called the Ex-servicemen (Re-employment in Central Civil Services and Posts) Amendment Rules, 2012.
 - (2) They shall come into force from the date of their publication in the Official Gazette.
 - In the Ex-servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979
 in rule 2, for clause (c), the following clause shall be substituted, namely:-
 - (c) An 'ex-serviceman' means a person -
 - (i) who has served in any rank whether as a combatant or noncombatant in the Regular Army, Navy and Air Force of the Indian Union, and
 - (a) who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his or her pension; or
 - (b) who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; or
 - (c) who has been released from such service as a result of reduction in establishment;

or

(ii) who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service;

OF

(iii) personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or circumstance beyond their control and awarded medical or other disability pension;

or

(iv) Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1987;

or

 (v) Gallantry award winners of the Armed forces including personnel of Territorial Army;

OF

- (vi) Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.
- (2) for rule 3, the following rule shall be substituted, namely:-
 - "3. Application These rules shall apply to all the Central Civil Services and Posts and the posts upto the level of Assistant Commandant in all paramilitary forces."

(3) in rule 4,-.

- (a) for sub-rule(I), the following sub-rule shall be substituted, namely:-
 - "(i) Reservation of vacancies: Ten per cent of the vacancies in the posts upto of the level of the Assistant Commandant in all para-military forces, ten per cent of the vacancies in

Group 'C' posts, and twenty per cent of the vacancies in Group 'D' posts, including permanent vacancies filled initially on a temporary basis and temporary vacancies which are likely to be made permanent or are likely to continue for three months and more, to be filled by direct recruitment in any year shall be reserved for being filled by exservicemen."

- (b) for sub-rule(2), the following sub-rule shall be substituted, namely:-
 - "(2) The Scheduled Castes, the Scheduled Tribes and the Other Backward Class candidates selected against the vacancies reserved for ex-servicemen shall be adjusted against vacancies reserved for Scheduled Castes, Scheduled Tribes and Other Backward Classes, respectively:

Provided that if a the Scheduled Caste or the Scheduled Tribe or the Other Backward Class ex-servicemen is selected against the vacancy reserved for ex-servicemen and vacancy reserved for the Scheduled Castes or the Scheduled Tribes or the Other Backward Classes, as the case may be, is not available to adjust such exserviceman, he shall be adjusted in future against the next available vacancy reserved for the Scheduled Castes or the Scheduled Tribes or the Other Backward Classes, as the case may be."

(c) after sub-rule (3), the following proviso shall be substituted, namely:-

"Provided that in case of recruitment to the vacancy reserved for Ex-servicemen in the Central Para Military Forces, the reserved vacancy remained unfilled due to non-availability of eligible or qualified candidates, the same shall be filled by candidates from non-ex-servicemen category".

- (4) for rule 5, the following rule shall be substituted, namely:-
 - "(5) (a) For appointment to vacancies in Group B(Non-Gazetted), Group C or Group D posts in Central Government, an exserviceman shall be allowed to deduct the period of actual military service from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post for which he is seeking appointment by more than three years, he shall be deemed to satisfy the condition regarding age limit.
 - (b) For appointment to any vacancy in Group A and Group B services or posts filled by direct recruitment otherwise than

on the results of an Open All India Competitive Examination, the upper age limit shall be relaxed by the length of military service increased by three years in the case of exservicemen and commissioned officers including Emergency Commissioned Officers or Short Service Commissioned Officers.

- (c) For appointment to any vacancy in Group A and Group B services or posts filled by direct recruitment on the results of an All India Competitive Examination, the exservicemen and Commissioned Officers including Emergency commissioned Officers or Short Service Commissioned Officers who have rendered atleast five years military services and have been released.
- (i) on completion of assignment (including those whose assignment is due to be completed within one year) otherwise than by way of dismissal or discharge on account of misconduct or inefficiency; or
- (ii) on account of physical disability attributable to military service or on invalidment, shall be allowed maximum relaxation of five years in the upper age limit.

Minutes of the meeting held under the Chairmanship of Shri Pudi Hari Prasad, Joint Secretary (ESW) on 28.03.2019 at 11:00 am to discuss grant of status of Exservicemen to MNS Officers and other issues pertaining to Exservicemen.

A meeting was held under the Chairmanship of Shri Pudi Hari Prasad, Joint Secretary (ESW) on 28.03.2019 at 11:00 am in his Chamber to discuss grant of status of Ex-serviceman to MNS Officers and other issues pertaining to Ex-servicemen. The meeting was attended by the following officers-

- (i) Shri G. Srinivasan, Director, DOP&T
- (ii) Lt Col A Pande, AAG PS-2
- (iii) Sh. Jitender Kumar, DS(Res-I)
- (iv) Smt. Suman Sharma, US(Res-I)

The following issues were discussed:-

Grant of status of Ex-serviceman to MNS Officers

It was informed that proposal for inclusion of Military Nursing Officers in the ambit of Ex-Servicemen (ESM) as outlined in DOP&T Notification dated the 4th October, 2012 has been taken up with twice with DOP&T after consultations with AG PS-2.. However, the same has been returned by DOP&T with the suggestion to explore possibility of inclusion of MNS Officers in the Regular Army.

The representative of AG PS-2 intimated that MNS officers cannot be included in the definition of regular army because of the following reasons:-

- · MNS Officers are not authorized to carry arms.
- Pay scales are different for Regular Army and MNS Officers.
- MNS Officers are not allowed to command troops.

Director, DOP&T appreciated the problem and suggested that the proposal may again be referred to DOP&T with detailed reasoning. Accordingly, AAG PS-2 was requested to furnish their comments in writing so that the matter may be taken up again with DOP&T.

2. Providing 20% reservation in Group 'C' and 10% in Group 'B' posts for Ex-Servicemen (ESM) for vacancies in the post to be filled by direct recruitment.

Director, DOP&T informed that they are consulting other Ministries/Departments regarding the case. However, the major Ministries i.e. Ministry of Home Affairs and Ministry of Railways have informed DOP&T that they are currently not being able to fill up more than 1% of the reserved vacancies for Ex-Servicemen. Hence, enhancing the reservation further may not be of any use.

available on the basis of prescribed standards to fill all the vacancies reserved for them, candidates belonging to the category of ESM may be selected under relaxed standards of selection to make up the deficiency in the reserved quota subject to the condition that such relaxation will not affect the level of performance by such candidates. D/o ESW may take up the matter with DOP&T to issue suitable instructions to Ministries/Departments for their strict compliance so that more vacancies reserved for ESM may be filled up.

3. Granting Statutory Powers to DGR by providing reservation for ESM on the lines of SC/ST/OBCs/PWD

Director, DOP&T informed that comments of Ministries/Departments have been sought. JS(ESW) requested that the matter may be followed up by DOP&T with concerned Ministries/Departments so that instructions are issued at the earliest.

4. <u>Proposal to include Short Service Commissioned Officers who obtained</u> release from service at their own request during the extended period of engagement in the category of 'Ex-Servicemen'

It was informed that based on the decision of Hon'ble High Court of Delhi in WP(C) No. 7302/2016 filed by Major Kapil Sawhney Vs. UOI & Others, this Department had suggested that all Short Service Commissioned Officers who have completed the initial term of engagement may be accommodated in the definition of 'Ex-Serviceman' by amending the definition as in Para 2(c)(ii) of the DOP&T Notification dated 04.10.2012 The file is being referred to DOP&T for amendment of their Notification dated 04.10.2012

Director, DOP&T after perusing the draft suggested to redraft the language to bring more clarity in the proposal. Thereafter only the proposal may be referred to DOP&T.

The meeting ended with vote of thanks to the Chair.
