Sub: Appointment on compassionate grounds-determination of vacancies

Sir / Madam,

This is in reference to this office letter of even number dated 12/04/2024, dated 08/08/2024, dated 28/08/2024 and 10/01/2025 vide which vacancies reserved for compassionate appointment falling under direct recruitment quota for the period ending 31-03-2024, period ending 30-06-2024 and period ending 31-12-2024 respectively were sought in a prescribed proforma (enclosed therewith) from various departments of GNCTD of Delhi.

2. In response to the above, various departments of GNCT of Delhi have submitted their vacancies report and upon perusal of these reports, it has been observed that some of the departments have not provided the vacancies status for appointment on compassionate ground according to the instruction laid down in para 7(b) of Master Circular issued by GOI vide DoPT's letter No. F. 14014/1/2022-Estt.(D) dated 02.08.2022 which stipulates that "*Compassionate appointments can be made upto a maximum of 5% of vacancies falling under direct recruitment quota in any Group 'C' post. The appointing authority may hold back upto 5% of vacancies in the aforesaid categories to be filled by direct recruitment through Staff Selection Commission or otherwise so as to fill such vacancies by appointment on compassionate grounds*".

3. The above instruction of DoPT's may be understood with the help of an illustration. Suppose the department 'A' has 500 sanctioned posts of Group 'C' including the post of MTS (erstwhile Group-D) and in a current year 100 vacant posts of Group 'C' including the post of MTS (erstwhile Group-D) arose in the department under direct recruitment quota due to the retirement/voluntary retirement/death/promotion of the employees. Hence, according to the above policy, 5% of vacancies to be hold back for compassionate appointment in the department will be equal to 5 posts i.e., 5% of 100 vacant posts arose for Direct Recruitment Quota in a particular year.


4. Accordingly, the departments may calculate and provide the vacancies that arose after the vacancies were last reported to Services Department (annexed as Annexure-A) and in case there is no change in vacancies then department need not respond. The departments which furnished a NIL report related to the vacancies for compassionate appointment may re-determinate vacancies for appointment on compassionate ground and if any vacancy has arisen subsequently, then the same may be communicated to Services Department, GNCT of Delhi.

5. Keeping in view of the above, all the departments of GNCT of Delhi are once again requested to comply with the above said directions to provide the updated status of vacancies as on 30.06.2025 i. e. 5% of the vacancies to be held back for compassionate appointment under direct recruitment quota of Group 'C' including MTS (erstwhile Group-D) arose in the department and to be filled through DSSSB or otherwise by **15-07-2025** positively.

6. This may be accorded **TOP PRIORITY** and information be furnished on the enclosed proforma for considering the cases for compassionate appointment.

7. This issues with the approval of the competent authority.
