On the recommendations of the Screening Committee constituted for grant of 3rd financial upgradation under the Modified Assured Career Progression Scheme to Private Secretary Re-deployed in GNCT of Delhi from DSMDC in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), Pr. Secretary (Services) is pleased to grant 3rd MACP benefits to the following official on completion of 30 years of regular service after including past regular services rendered at DSMDC from the existing pay scale Rs. 9300-34800 Level 8(Grade Pay of Rs. 4800/- under 6th CPC) to immediate next higher Level 9 in Pay Matrix table as given in Part A of Schedule of the CCS(Revised Pay) rule, 2016 under 7th CPC (Grade Pay of Rs. 5400/- in PB II under 6th CPC). w.e.f. the date mentioned against his name :-

The grant of MACP is further subject to the condition that:

- 1) No further financial upgradation under MACP would be admissible to these officers.
- 2) The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 3) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- 4) The Official who is on deputation will get financial upgradation from the dates shown against his name only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.



5) The concerned Head of Department is requested to ensure before issuance of formal order for grant of 3rd financial upgradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.

6) It should be re-ensured by concerned Head of Department that the above-mentioned Official is absolutely clear from vigilance angle at all levels at the time of eligibility.

7) The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation under MACP Scheme in respect of the above-mentioned Official after verifying and checking the service particulars with regard to date of appointment etc as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official(s) may not be implemented till clarification from this Department.
