Madam/Sir,

I am directed to enclose herewith the letter No. 14016/09(i)/2014-UTS-II dated 02.09.2022 of MHA, GoI, and Ministry subsequent reminder letter dated 21.03.2023 along with its enclosures, which are draft promotional orders in respect of DANICS officers (or promoted IAS officers) that are to be revised with request to work out the estimated additional financial burden as a result of proposed revision of effective date of promotion on a case to case basis in respect to the DANICS officers (or promoted IAS officers) posted in your respective department, in light of the following instances.

- a) Pay and allowance may increase on date which officer(s) assumed charges of the post on actual basis as per pay in lower post and as per the option exercised by the officer under FR 22(I)(a)(1).
- b) Pay fixation done at the time of switch over from 5th CPC to 6th CPC and 6th CPC to 7th CPC.
- c) At the time of further pay up gradation of the officer (s) including promotion, grant of ACP/MACP/NFU etc.
- d) In case officer(s) gets any advance increments(s) or special increment(s) on the basis of his basic pay.
- e) At the time of revision of rate of Dearness Allowance.

The above instances are not exhaustive. Instances may vary as per the service conditions of the officer(s) concerned and the same may be considered by the respective department(s) for estimation of financial implication involved as requisite by Ministry of Home Affairs vide their above referred letters dated 02.09.2022 and 21.03.2023.

Furthermore, since, the service records of the officers posted in respective departments are maintained and available with the concerned departments where the officers are posted, accordingly, it is requested to submit a report regarding financial implication involved in case MHA decides to grant notional promotion to the concerned officer from retrospective date as per enclosed draft orders. The requisite report may be submitted to this office as per available service records available with the respective department of the officer concerned as per list attached (Annexure – 1 & II), at the earliest for its onward transmission to the Ministry.


