On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme (MACP) to Grade-II (DASS) Officers in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), the Secretary (Services) is pleased to grant 2nd financial upgradation under MACP Scheme to Sh. Narendra Kumar, Gr.II(DASS)/A.S.O(Now Gr.I) from existing Grade Pay of Rs. 4600/- (P.B-II) to the immediate next higher grade pay of Rs. 4800/- (P.B-II) in the hierarchy of the recommended revised pay bands on completion of 20 years of regular service with only one financial upgradation w.e.f 24/07/2010 as under:-

The Officer concerned may be allowed to exercise the option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal order for grant of the 2nd financial upgradation in respect of Sh. Narendra Kumar working in their Department. However, before the issuance of the formal order the Head of Department may again confirm that the Officer has completed 20 years regular service with one promotion/financial upgradation and is clear from Vigilance angle.

In case the Officer is on deputation, he will get financial upgradation from the date shown against his name only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of the repatriation to Delhi Government.
