If any of the official(s) (as per list enclosed as Annexure-A) has expired/ resigned/removed from service, promoted/appointed to higher grade/post or transferred/sent on deputation to other department, then the necessary information may be provided to this department. Service particulars of the officials, with regard to the above, may also be sent to this department so that further correspondence can be made as and when required.

It may be noted that only those officials will be considered whose record is made available and in case any official does not get considered due to nonfurnishing of requisite documents/papers/information by the concerned Department, the responsibility shall rest with the concerned Department.

This may be treated as **MOST URGENT** and necessary documents may be furnished to this department at the earliest.
