**ORDER NO. 97**

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to Grade-IV (DASS)/Jr. Assistant Officials in accordance with the instructions contained in O.M. No. 35034/1/97 Estt.(D) dated 09.08.1999 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary (Services) is pleased to grant 2<sup>nd</sup> financial upgradation under ACP Scheme to the following Grade-IV(DASS)/Jr. Assistant Officials initially appointed as Class-IV Officials on completion of 24 years of regular service with only one promotion / financial upgradation from existing pay scale of Rs.3050-4590/- (Revised as Rs 1900/- G.P under 6<sup>th</sup> CPC) to the next higher pay scale in promotional hierarchy of DASS Cadre i.e Rs.4000-6000/- (Revised to Rs 2400/- G.P under 6<sup>th</sup> CPC) w.e.f. the date mentioned against their names:-
