On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme (ACP) to the then Grade-IV (DASS) Officials re-deployed from DEDA/DSMDC in accordance with the instructions contained in DoPT, Govt. of India O.M NO. 35034/1/97-Estt.(D) dated 09/08/1999 , Circular dated 29.07.15 regarding counting of past service rendered at DEDA/DSMDC & the policy decision of the Department circulated vide letter dated 03.06.19, the Secretary (Services) is pleased to grant benefits of 1<sup>st</sup> financial upgradation under ACP Scheme to the following Official re-deployed from DSMDC from the existing pay scale of Rs.4000-6000 (S-7) to next higher pay scale Rs. 4500-7000 (S-8) in accordance with policy decision circulated vide letter dated 03.06.19. w.e.f. the date mentioned against his name:

The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal order for grant of the 1st financial upgradation in respect of the above-mentioned Official. However, before the issuance of the formal orders the Heads of Departments may again confirm that the official has completed 12 years of regular service with no promotion / financial upgradation and is clear from Vigilance angle. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits.


