ORDER *108*

On the recommendations of the Screening Committee constituted for grant of 2nd financial upgradation under the Modified Assured Career Progression Scheme to Grade-IV/ III (DASS) in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training) and the policy decision taken by the Department circulated vide letter dated 03.06.19, the Secretary (Services) is pleased to grant 2nd MACP benefits on completion of 20 years of regular service including regular service rendered at DEDA/DSMDC in terms of circular dated 29.07.15 from existing pay scale of Rs.9300-34800 (P.B-II) with Grade Pay of Rs. 4200 to immediate next higher Grade Pay of Rs. 4600 (PB-II) in the hierarchy of the recommended revised pay band to the following Grade-III (DASS) Officials w.e.f. the date mentioned against their names :-

The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

All the concerned HODs may ensure before issue of final orders that concerned Officials have not been given more than one financial upgradation / promotion and have completed 20 years of regular service including past services at DEDA/DSMDC prior to re-deployment in GNCT of Delhi. Ad-hoc / temporary service period shall not be counted for grant of MACP benefits. Any financial up-gradation granted to the official without counting of past service at DEDA/DSMDC shall stand modified accordingly.

The concerned Head of Departments are requested to issue formal order for grant of the 2nd financial upgradation in respect of the above-mentioned Officials working in their Departments. However, before the issuance of the formal orders, the Heads of Departments may again confirm that these officials have completed 20 years regular service with only one financial upgradation / promotion and are clear from Vigilance angle.
