ORDER No. 23

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Gr. II (DASS)[Now Gr. I (DASS)] officials in accordance with the instructions contained in OM No.35034/1/97-Estt.(D) dated 9.8.99 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to nominate the following Gr. II (DASS)[Now Gr. I (DASS)] officials for grant of 2nd financial up-gradation in the pay scale of Rs.6500-10500 (Pre-revised) w.e.f. the dates mentioned against their names:-

The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the understanding that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Departments are requested to ensure before issuing final order that 24 years of regular service of the official does not include the period of past service rendered in Autonomous body/Statutory body/State government as the period of past service in these bodies is not to be counted for grant of financial upgradation under ACP Scheme. (Clarification No.43 of DoPT OM dated 18.07.2001).

The Head of Departments/Head of Offices are requested to ensure before issuing the final order that the above officials have fulfilled the requirement as mentioned in Point No 4 and 5.1 of Annexure-1 of ACP Scheme introduced by DoPT, Govt. of India.

The concerned Head of Departments are requested to ensure before issuing final order that official is clear from vigilance angle.

The concerned Head of Departments/Head of Offices are, however, requested before issuing the formal order for the grant of 2nd financial up-gradation in respect of the above officials, to confirm again that these officials have completed 24 years of regular service in the Govt. of NCT of Delhi on the date of granting financial up-gradation with one promotion.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
