Circular Memorandum

It is proposed to fill up vacancies in the following ranks in the Intelligence Bureau under the Ministry of Home Affairs on absorption/deputation (including short term contract basis) as mentioned below. The educational qualifications, experience and other eligibility conditions for the post are furnished below.


