However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered.

The Head of Department concerned are requested to ensure before issuing final order that 30 years of regular service of the official does not include the period of service rendered in State Government/ statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09).
