**ORDER No. 4**

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Career Progression Scheme to Gr. III (DASS)/UDC officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training), the Pr. Secretary (Services) is pleased to grant the following **01** Gr. III (DASS)/UDC official on the completion of 30 years regular service with two promotions third financial upgradation from the corresponding Pay Band-I of Rs. 5200-20200/-; Grade Pay of Rs. 2400/- to the immediate next higher Grade Pay of Rs. 2800/- in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against his name:-

The Official concerned may be allowed to exercise his option if any under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The Head of Department concerned is requested to ensure before issuing final order that 30 years regular service of the official does not include the period of service rendered in State Government/statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP scheme. (Point No. 10 of DoPT OM dated 19.05.09).

The concerned Head of Department is requested to issue formal orders for grant of the 3<sup>rd</sup> financial upgradation in respect of the above mentioned official working in their Department. However, before the issuance of the formal order the Head of Department may again confirm that the official has completed 30 years regular service with two promotions since the date of his initial appointment in the service and is **clear from Vigilance angle.**

The official, in case, on deputation will get financial upgradation from the dates shown against his names only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
