On the recommendation of the Screening Committee constituted for grant of 3rd financial up-gradation under the Modified Assured Career Progression Scheme to Gr-IV(DASS) officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Dep't. Of Personnel & Training), the Pr. Secretary (Services) is pleased to grant of following 01 Gr-IV(DASS) official on completion of 30 years of regular service with/without promotion in the PB-I pay scale of Rs. 5200-20200/- with present grade pay of Rs. 1900/- to the immediate next higher grade pay of Rs. 2000/- in the hierarchy of the revised pay bands w.e.f. the date mentioned against his name:-

The official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial up gradation under the modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered from his pay.

The Head of Department concerned is requested to ensure before issuing final order that 30 years of regular service of the official does not include the period of service rendered in State Government/ statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09).

The concerned Head of Department is requested to issue formal order for grant of 3rd financial up gradation in respect of above mentioned official working in their Department. However, before issuing formal order again confirm that the official has completed 30 years of regular Service since the initial appointment in the service and are **clear from Vigilance Angle**.

The official, in case, on deputation will get financial up gradation from the dates shown against his name only on notional basis. However, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
