**ORDER No. 47**

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Career Progression Scheme to Gr. II (DASS) officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training), the Pr. Secretary (Services) is pleased to grant the following 02 Gr. II (DASS) officials on the completion of 30 years regular service with two promotions third financial upgradation from the corresponding Pay Band-II of Rs. 9300-34800/-; Grade Pay of Rs. 4200/- to the immediate next higher Grade Pay of Rs. 4600/- in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against their names:-

The Officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of Department concerned is requested to ensure before issuing final order that 30 years regular service of the officials does not include the period of service rendered in State Government/statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP scheme. (Point No. 10 of DoPT OM dated 19.05.09).

The concerned Heads of Departments are requested to issue formal orders for grant of the 3<sup>rd</sup> financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 30 years regular service with two promotions since the date of their initial appointment in the service and are **clear from Vigilance angle**.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.


