**ORDER 06**

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Stenographers Gr.III officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training), the Secretary (Services) is pleased to grant 1<sup>st</sup> financial upgradation to the following Stenographer Gr.III official, on completion of 10 years of regular service without any promotion, from the corresponding Pay Band--1 of Rs. 5200-20200/- Grade Pay 2400/- to the immediate next higher Grade Pay of Rs.2800/- in the hierarchy of the recommended revised pay band w.e.f. the date mentioned against his name:-


The official,concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The Head of Department concerned is requested to ensure before issuing final order that 10 years of regular service of the official does not include the period of service rendered in State Government /Statutory Body/ Autonomous Body/ Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No.10 of DoPT OM dated 19.05.09).

The concerned Head of Department is requested to issue formal order for grant of the 1<sup>st</sup> financial upgradation under MACP Scheme in respect of the above mentioned official working in his Department. However, before the issuance of the formal order the Head of Department may again confirm that the official has completed 10 years of regular service without any promotion since the date of his initial appointment in the service and is **clear from Vigilance angle.**

The official if on deputation will get financial upgradation from the date shown against his name only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to the Delhi Government.


