The official concerned may be allowed to exercise her option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from her pay.

The Head of Department concerned is requested to ensure before issuing final order that 20 years of regular service of the official does not include the period of service rendered in State Government /Statutory Body/ Autonomous Body/ Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No.10 of DoPT OM dated 19.05.09).

The concerned Head of Department is requested to issue formal order for grant of the 2nd financial upgradation under MACP Scheme in respect of the above mentioned official working in his Department. However, before the issuance of the formal order the Head of Department may again confirm that the official has completed 20 years of regular service with one financial upgradation or 10 years of regular services in the same pay scale since the date of her initial appointment in the service and is **clear from Vigilance** angle.

The official if on deputation will get financial upgradation from the date shown against her name only on notional basis, however, she will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of her repatriation to the Delhi Government.
