Of Personnel & Training), the Secretary (Services) is pleased to grant 3rd financial upgradation to the following Stenographers Gr.II officials, on completion of 30 years of regular service with two financial upgradations or 10 years of regular services in the same pay scale, from the corresponding Pay Band–2 of Rs. 9300-34800/- Grade Pay 4800/- to the immediate next higher Grade Pay of Rs.5400/- in Pay Band-2 in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against their names:-

The officials concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of Departments concerned are requested to ensure before issuing final order that 30 years of regular service of the official does not include the period of service rendered in State Government /Statutory Body/ Autonomous Body/ Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No.10 of DoPT OM dated 19.05.09).

The concerned Head of Departments are requested to issue formal order for grant of the 3rd financial upgradation under MACP Scheme in respect of the above mentioned official working in their Departments. However, before the issuance of the formal order the Head of Departments may again confirm that the official has completed 30 years of regular service with two financial upgradations or 10 years of regular services in the same pay scale since the date of their initial appointment in the service and are clear from Vigilance angle.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to the Delhi Government.
