On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme (MACP) in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), the Secretary (Services) is pleased to grant 3<sup>rd</sup> financial upgradation under MACP Scheme to Grade- I (DASS) / Sr. PA Officers who were initially appointed as Steno Grade-III on completion of 30 years of regular service from the corresponding Pay Band-2 of Rs. 9300-34800/- Grade Pay of Rs. 4800/- to the immediate next higher grade pay of Rs. 5400/- (Pay Band-2) (Level 8 to Level 9 of Pay Matrix table under 7<sup>th</sup> CPC) in the hierarchy of the recommended revised pay bands on completion of 30 years of regular service with two promotion/financial upgradation w.e.f. the date mentioned against their names:


However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
