## ORDER No.118

On the recommendations of the Screening Committee constituted for grant of 2<sup>nd</sup> financial upgradation under the Modified Assured Career Progression Scheme to Steno (Grade III) in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training) and the policy decision taken by the Department circulated vide letter dated 03.06.19, the Secretary (Services) is pleased to grant 2<sup>nd</sup> MACP benefits to the following officials on completion of 20 years of regular service after including past regular services rendered at DEDA/DSMDC in terms of circular dated 29.07.15 from the existing pay scale of Rs. 9300-34800 in PB-II with Grade Pay from 4600 to the immediate next higher grade pay of Rs. 4800/- w.e.f. the date mentioned against their names:-

The Officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned HODs may ensure before issue of final orders that the officials have not been given more than one financial upgradation / promotion and completed 20 years of regular service for 2nd Financial upgradation during their tenure including past services at DEDA/DSMDC prior to re-deproyment in GNCT of Delhi. Ad-hoc / temporary service period shall not be counted for grant of MACP benefits. Any financial up-gradation granted to the official without counting of past service at DEDA/DSMDC shall stand modified accordingly.

The concerned Head of Departments are requested to issue formal order for grant of the 2<sup>nd</sup> financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 20 years regular service with one financial upgradation / promotion and are clear from Vigilance angle.
